# WEISER CENTER FOR EMERGING DEMOCRACIES

From the Director

It was a busy and productive year at the Weiser Center for Emerging Democracies. Our fall programming highlights included a roundtable on the elections in Kenya, a performance by Bassem Youssef on free speech under dictatorship, and a roundtable about the Egyptian Arab Spring and its aftermath. In the winter we hosted a talk by Ambassador Daniel Fried on the West's democratic challenge and organized a roundtable on separatist and autonomy movements in Europe. In March we organized a presentation by Masha Gessen and Misha Friedman on their WCED-supported project, "Searching for Stalin's Gulags in Putin's Russia," and also welcomed Chairman Chito Gascon, embattled head of the Philippines Human Rights Commission.

As part of our outreach mission we also hosted or supported a number of students, faculty, and visitors. In the fall we welcomed three new post-doctoral fellows and nine first-year graduate fellows. Thanks to the generous support of Ronald and Eileen Weiser and the College of Literature, Science, and the Arts, we also secured the funding to add a fourth post-doctoral fellow each year and convert the fellowship into a two-year appointment. In addition, over the course of the year we supported a number of research projects from U-M faculty, and were also pleased to host six Weiser Professional Development Fellows in cooperation with WCEE.

WCED hosted its third annual NGO Leadership Workshop in Bratislava, Slovakia in October 2017. The workshop is an innovative program designed to strengthen civil society in new and emerging democracies by providing management training to non-governmental organizations (NGOs). WCED has partnered with the William Davidson Institute

(WDI) at the University of Michigan and Slovak-based Pontis Foundation for all three workshops. In 2017, additional funding for the program came from the National Endowment for Democracy. Over the course of the workshops, 70 NGO leaders from 17 countries have participated. They represent NGOs that focus on democracy, economic development, environment, human rights, youth, and civil society. With this investment into building strong and sustainable organizations, NGO leaders can bolster their organizations and help citizens in their home countries advance positive social and political change. Plans are underway to conduct a fourth NGO Leadership Workshop in 2018, this time in Poland.

Finally, this summer marks the end of my two-year term as interim director of WCED. I want to thank the amazing WCED staff for their excellent work, dedication, and patience throughout my tenure. I offer a warm welcome to Professor Dan Slater who will serve as director starting July 1. With Dan at the helm and our excellent staff at his side, WCED is in great hands.



# WEISER CENTER FOR FUROPE & FURASIA

From the Director

The Weiser Center for Europe and Eurasia (WCEE) and its affiliated centers—the Center for European Studies (CES); Center for Russian, East European, and Eurasian Studies (CREES); and Copernicus Program in Polish Studies (CPPS)—had a very stimulating year.

We developed a rich program articulated around two main themes. The first, Populism, explored what fuels the rise of populism in various parts of Europe, Eurasia, and beyond. Speakers in this series discussed genealogies and varieties of populism, and pondered how 21st-century populisms are related to other key phenomena of our times globalization, neoliberalism, and pluralism. The other series focused on Regionalism, featuring scholars who discussed the meaning of regionalism at the twin age of nationalism and European Unionism. Speakers discussed the political and academic formation and transformation of regions like "Europe," "Eastern Europe," or "the Balkans," and reflected on the implications of reframing regional boundaries for our understanding of various societies. As always, we remain grateful to our partners within WCEE and beyond, especially WCED, the Department of History, UMS, and the Michigan Theater.


WCEE was pleased to continue our partnership with the Robert B. Zajonc Institute of Social Studies (ISS) at the University of Warsaw by hosting one PhD candidate for six weeks in the fall. We are expanding student internship opportunities: 30 students from LSA and beyond are in the region this summer pursuing internships with organizations including POLIN: The Museum of the History of Polish Jews and the Adam Mickiewicz Institute in Warsaw (Poland), the Youth Initiative for Human Rights in

Zagreb (Croatia), the Fulbright Commission and Comenius University in Bratislava (Slovakia), the Bellini Music School in Tradate (Italy), the Kosovar Institute for Policy Research and Development in Prishtina (Kosovo), as well as the National Coastal Agency and European Movement in Tirana (Albania).

Last but not least, WCEE is hosting six scholars from Eurasia as part of our Professional Development Program in 2018. Four visited this spring, and the remaining two scholars will come to campus in September. These scholars are working with U-M counterpoints in education, public policy, political science, mathematics, and the Slavic department. #### **CENTER FOR EUROPEAN STUDIES**

CES programming focuses on the past, present, and future of Europe and the European Union. In our Regionalism series, U-M professor Scott Greer presented a lecture on the impact of Brexit on Scotland and Ireland, and we organized a roundtable with WCED on regionalism and separatism in Western Europe, with specialists discussing Catalonia and Scotland. We also hosted a lecture on leftwing populism in Spain and co-sponsored multiple events with WCED; CPPS; the Law School; and the Departments of History, History of Art, and Germanic Languages & Literatures.

We were honored to have Jan-Werner Müller, professor and author, give the Annual Distinguished Lecture on Europe, titled "What's the Problem with Populism?" Müller's lecture and the symposium "The Practice of History" were both dedicated to Professor Kathleen Canning, former CES Director (1995-98), on the occasion of her departure from U-M.

To mark the 50th anniversary of the revolutions of 1968, we organized a roundtable to reflect on events in France, Czechoslovakia, and Germany. We coordinated that panel discussion with three screenings at the Michigan Theater of feature films touching upon these events.

CES continues to offer an undergraduate minor and a graduate certificate, and we award Jean Monnet Graduate Fellowships and CES Summer Research & Internship Grants to students studying Europe. Thank you to the CES Advisory Committee members who gave their time to read through our many fellowship applications. CES is proud to support established scholars and rising stars who are continuing the long tradition of European studies at U-M.

#### **CENTER FOR RUSSIAN, EAST EUROPEAN, & EURASIAN STUDIES**

CREES organized a diverse series of events in 2017-18, featuring guest lectures, exhibits, films, and concerts. Speakers in our Regionalism series included historians, political scientists, sociologists, and journalists who discussed themes as varied as ethnopolitical mobilization in Poland's upper Silesia; conflicts in Russia's North Caucasus; the scholarly impact of reconceptualizing Southern Europe as a maritime region rather than defining it around a land mass; and representations of Turks and the "East" in early Modern Europe. Our Populism series focused on Poland and Russia, featuring lectures by U-M historian Brian Porter-Szűcs; Russian investigative journalist Andrei Soldatov; and human rights activist Tanya Lokshina, who discussed populist politics of Russia's Putin and Chechnya's Kadyrov. Populism and authoritarian politics were also discussed by former Ambassador to Poland Daniel Fried and former Ambassador to Russia John R. Beyrle in lectures we co-sponsored with WCED and the Ford School of Public Policy, respectively. Our events were organized or co-sponsored by a number of campus partners including the Department of Slavic Languages & Literatures, Frankel Center for Judaic Studies, Law School, and the Penny Stamps Distinguished Speaker Series.

We were also proud to collaborate with the University Musical Society (UMS) on the *Us/Them* performance by BRONKS and Richard Jordan Productions, which explored the reaction of children to tragic events and was inspired by the Beslan school siege in North Ossetia, Russia. UMS also was our partner for a special performance by the M-Prize winner Russian Renaissance, for which we organized an intimate concert and get-together for our Russian-language students with members of the Russian folk quartet.

Beyond public programming, CREES supports students through fellowships that enhance a deeper understanding of the region. #### **COPERNICUS PROGRAM IN POLISH STUDIES**

The 2017-18 academic year was a rich one for CPPS. In addition to lectures by Brian Porter-Szűcs on populism and Magdalena Dembinska on Silesian regionalism, we co-sponsored a lecture by Daniel Fried, former U.S. Ambassador to Poland. We also brought Agnieszka Holland's latest film, *Pokot*, to Ann Arbor for a screening at the Michigan Theater. We continue working with the Ann Arbor Polish Film Festival to bring to the U-M community a variety of Polish fiction and documentary films.

CPPS is strengthening our ties with partner institutions in Poland by sponsoring faculty and student initiatives with POLIN Museum of the History of Polish Jews, the Adam Mickiewicz Institute, and the University of Warsaw. As always, we support our students by awarding numerous fellowships to study the Polish language and to travel to Poland for research or internships. This year CPPS sponsored 13 scholarships for students who are studying Polish at U-M, and we plan to continue this program that supports undergraduate language learning in partnership with the Slavic department.

Finally, CPPS Director Geneviève Zubrzycki, professor of sociology, has been called upon to use her expertise on Polish-Jewish relations to comment on the Polish bill signed into law in February. That law criminalizes speech that implies Poland's participation in the Holocaust. Zubrzycki addressed the new law and how it impacts Polish relations with Israel and the United States, offering much needed historical context to the issue and explaining how it speaks to broader questions of Polish identity. She appeared on NPR, CBS (Canada), and ABC radio (Australia), and was cited by the Washington Post and Times Higher Education.


